About This Agreement, Our Services, and Your Rights

Services will be provided to you ("you," "your," or "Customer") on the terms and conditions set forth in this Service Agreement (the "Agreement") by Waitsfield and Champlain Valley Telecom and its subsidiaries that own and/or operate the cable television system, broadband, or phone services in your area ("WCVT," "we," "us," or "our") and in any applicable Tariff(s) on file with the FCC, state public utility commission(s) or other comparable state agency. Services may include, but are not limited to, GMA Video Service / Waitsfield Cable ("Video"), Green Mountain Access High-Speed Internet service ("Broadband"), WCVT voice services including Hosted IP Voice service and those that may that operate over a broadband connection or other local facility, and Apps and other Software we may provide (each a "Service" and collectively, "Services").

About This Agreement

<u>Acceptance.</u> Your use of Services provided by WCVT requires you to accept the terms of service outlined in this Agreement. You will have accepted this Agreement and agreed to be bound by its terms if you use the Services or otherwise indicate your affirmative acceptance of such Services.

<u>Updates.</u> This Agreement may be updated or changed from time to time. If WCVT makes a change to this Agreement and the change has a material impact on the Services, you will be provided notice of that change. Unless this Agreement or applicable law specifies otherwise, we will give you no less than thirty (30) days' prior notice of any significant change to this Agreement. If we do give you notice it may be provided on your monthly bill, as a bill insert, in a newspaper, via email, or other communication permitted under applicable law. If you find the change unacceptable, you have the right to cancel your Service(s) however if you continue to receive Service(s) after the end of the notice period (the "Effective Date") of the change, we will consider that you have accepted the changes.

<u>Change in Features and Equipment.</u> WCVT reserves the right to change WCVT-provided equipment and to rearrange, delete, add to or otherwise change programming or features or offerings contained in the Services, including but not limited to, content, functionality, hours of availability, and customer equipment requirements at any time with or without notice.

Charges and Billing

Charges, Fees, and Taxes That You Must Pay. You agree to pay all charges associated with the Services, including, but not limited to, installation charges (including reconnect, premise visit, and constructions fees that may apply), monthly service charges, WCVT Equipment (as defined below) charges, service call charges, measured and per call charges, applicable federal, state, and local taxes (however designated) and any fees or payment obligations imposed by governmental or quasi-governmental bodies for the sale, installation, use, or provision of the Services. You agree to pay any regulatory recovery fees which WCVT invoices you for municipal, state and federal government fees or assessments imposed on WCVT, or any programs in which WCVT participates, including, but not limited to, public, educational and governmental access, universal service, and rights-of-way access. You will be responsible for paying any government-imposed fees and taxes that become applicable retroactively. We will provide you with notice and an effective date of any change in our prices or fees, unless the change in price is related to a change in governmental or quasigovernmental taxes, fees or assessments, in which case we may elect not to provide notice except where required by applicable law. Not all fees apply to all Services.



How We Will Bill You. Unless you have signed a minimum term agreement, Services are provided to you on a month-to-month basis. You will generally be billed monthly, in advance, for recurring service charges, equipment charges, and fees. In addition, you may be required to pay, on or before the day we install any or all of the services, the first month's service charges, WCVT equipment charges, any deposits, and any installation charges. You may be billed for some Services individually after they have been provided to you; these include measured and percall charges (as explained below) and charges for pay-per-view movies or events, interactive television, and e-commerce.

Your first bill may include pro-rated charges from the date you first begin receiving Services, as well as monthly recurring charges for the next month and charges for non-recurring charges for any nonrecurring services you have received. If you make partial payment of any bill, we will apply that payment to the outstanding charges in the amounts and proportions that we determine, <u>pursuant to the law</u>. However, we do not waive our rights to collect the full balance owed to us by accepting partial payment.

<u>Third-Party Charges That Are Your Responsibility.</u> You acknowledge that you may incur charges with third-party service providers that are separate and apart from the amounts charged by us. These may include charges resulting from accessing on-line services, purchasing or subscribing to other offerings via the Internet or Interactive options on your Video Service, if applicable, or otherwise. You are solely responsible for all charges payable to third parties, including all applicable taxes. In addition, you are solely responsible for protecting the security of payment and other personal information provided to others in connection with such transactions.

<u>Alternative Billing Arrangements.</u> In certain cases, WCVT may agree to provide billing services on behalf of third parties, as the agent of the third party. Any such third-party charges shall be payable pursuant to any contract or other arrangement between you and the third party. We shall not be responsible for any dispute regarding these charges between you and any third party. You must address all such disputes directly with the third party.

Payment by Credit Card, Debit Card, or Check. Customer hereby authorizes WCVT to charge Customer's debit or credit card, invoice customer, or use other billing option in accordance with WCVT's then-current billing policies, for all such fees, charges and taxes. Customer agrees to pay for WCVT Service through the end of the term or in accordance with WCVT's then-current billing policies. If you use a credit card to pay for Services that use is governed by the card issuer agreement for that card you must refer to that agreement for your rights and liabilities as a cardholder. If WCVT does not receive payment from your credit card issuer or its agents, you agree to pay all amounts due upon demand. If you make payment by check, you authorize WCVT to collect your check electronically. You agree that you



may not amend or modify this Agreement with any restrictive endorsements (such as "paid in full"), releases, or other statements on or accompanying checks or other payments accepted by WCVT and that any such notations shall have no legal effect.

WCVT will charge you a fee for any check or other instrument (including credit card charge backs) tendered by you and returned unpaid by a financial institution for any reason.

Our Remedies if You Pay Late or Fail to Pay

Late or Non-Payments. An invoice is considered delinquent if you fail to pay within twenty-three (23) days of the bill date ("Payment Due Date"). You may be billed fees, charges and assessments related to late payments or non-payments if for any reason (i) WCVT does not receive from you any required payment for the Services by the Payment Due Date or (ii) you pay less than the full amount due for the Services. All balances not paid by the Payment Due Date may be subject to monthly service charge of the lesser of 1½ percent or the maximum amount allowed by law.

<u>Fees Not Considered Interest or Penalties.</u> WCVT does not anticipate that you will fail to pay for the Services on a timely basis, and we do not extend credit to customers. Any fees, charges, and assessments due to late payment or nonpayment are not interest, credit service charges, or finance charges or penalties. Rather, they are liquidated damages intended to be a reasonable advance estimate of our costs resulting from late payments and non-payments. These costs will be difficult to calculate or to predict when we set such fees, charges, and assessments, because we cannot know in advance: (a) whether you will pay for the Services on a timely basis, if ever; (b) if you do pay late, when you will actually pay; and (c) what costs we will incur because of your late payment or non-payment.

<u>Collection Costs.</u> If we are required to use a collection agency or attorney to collect money owed by you, you agree to pay the reasonable costs of collection that we may choose to assess to you. These costs include but are not limited to any collection agency's fees, reasonable attorneys' fees, and arbitration or court costs.

<u>Suspension/Disconnect.</u> If you fail to pay the full amount due for any or all of the Services then WCVT, at its sole discretion and in accordance with applicable law, may suspend or disconnect any or all the Services you receive.

<u>Reconnection Fees and Related Charges.</u> Should you wish to resume a Service after any suspension, we may require you to pay a reconnection fee. Should you wish to reinstate any or all Services after disconnection, we may require you to pay an installation fee and/or service activation fee. These fees are in addition to all past due charges and other fees. Reconnection of the Services is subject to our credit policies, this Agreement and applicable law.



Our Right to Make Credit Inquiries. YOU AUTHORIZE WCVT TO MAKE INQUIRIES AND TO RECEIVE INFORMATION ABOUT YOUR CREDIT EXPERIENCE FROM OTHERS, TO ENTER THIS INFORMATION IN YOUR FILE, AND TO DISCLOSE THIS INFORMATION CONCERNING YOU TO APPROPRIATE THIRD PARTIES FOR REASONABLE BUSINESS PURPOSES.

<u>Credit Policy.</u> Unless otherwise required by law, WCVT is not obligated to furnish any services to any individual subscriber or company that owes WCVT for previous service until arrangements have been made for that indebtedness to WCVT.

At WCVT's sole discretion, any subscriber that has no previous credit history with WCVT may be required to pay a deposit or submit to a credit check.

Your Responsibilities Concerning Billing Questions. Subject to applicable law, if you intend to dispute a charge or request a billing credit, you must contact WCVT within sixty (60) days of the date on the bill. You waive any disputes or credits that you do not report within sixty (60) days.

Refundable Deposit

We may require you to pay a refundable deposit when you activate the Service(s). We may also require you to pay a refundable deposit after activation of the Service(s) if you add WCVT Equipment and/or Service(s) or if you fail to pay any amounts when they are due hereunder. If we disconnect your Service(s) or are otherwise required under applicable law to refund the deposit, we shall within forty-five (45) days or as otherwise specified by applicable law return a sum equal to the deposit(s) you paid (without interest unless otherwise required by law) minus any amounts due on your account (including without limitation, any amounts owed for Services or for any WCVT Equipment that is damaged, altered, or not returned).

Access to Your Premises

You will provide WCVT and its subcontractors with reasonable access to your premises in order to install, maintain, and repair the Service and you authorize any other adult resident or guest at your residence to grant access to your premises for these purposes. Our installers reserve the right to refuse to access a premise when, in the installer's sole determination, that such access is unsafe or otherwise compromises the ability of the installer to provide the requested service.

You understand and agree that WCVT may drill, cut, and otherwise alter the premises (including walls, flooring, and/or other surfaces). If you do not own your premises or your unit is part of a multi-tenant environment (e.g., apartment building, condominium, private subdivision), you warrant that you have obtained permission from any necessary party, including but not limited to the owner, landlord, or building manager, to make alterations WCVT deems appropriate for the work to be performed.



You acknowledge that WCVT may use existing wiring, including altering the wiring and removing accessories, located within your unit ("Inside Wiring"). You warrant that you own or control the Inside Wiring, and give WCVT permission to use, alter, and remove equipment from, such wiring. Without limiting any other provisions of this Agreement, you agree to indemnify WCVT from and against all claims by an owner, landlord, building manager, or other party in connection with installation, maintenance, repair, or provision of the Services.

Maintenance and Ownership of Equipment

WCVT Equipment. You agree that except for the wiring installed inside the Premises ("Inside Wiring"), all WCVT equipment belongs to us and will not be deemed fixtures or in any way part of the Premises. WCVT Equipment includes all new or reconditioned equipment installed, provided or leased to you by us or our agents, including but not limited to, cabling or wiring and related electronic devices such as set-top boxes, any other hardware, and all software or "downloads" to WCVT Equipment. You agree to use WCVT Equipment only for the Services pursuant to this Agreement. We may remove or change the WCVT Equipment at our discretion at any time the Services are active or following the termination of your Service(s). You agree to allow us access to the Premises for these purposes. You may not sell, lease, abandon or give away the WCVT Equipment, or permit any other provider of video or high-speed data to use the WCVT Equipment. The WCVT Equipment may only be used in the Premises. At your request, we may relocate the WCVT Equipment in the Premises for an additional charge, at a time agreeable to you and us. You understand and acknowledge that if you attempt to install or use the WCVT equipment or services at a location other than the Premises, the services may fail to function or may function improperly. You agree that you will not allow anyone other than WCVT employees or agents to service the WCVT Equipment. You will be directly responsible for loss, repair, replacement and other costs, damages, fees, and charges if you do not return the WCVT Equipment to us in an undamaged condition.

<u>Customer Equipment.</u> WCVT has no responsibility for the operation or support, maintenance or repair of any equipment, software, or services that you elect to use in connection with the Services or WCVT Equipment ("Customer Equipment".) You will be responsible for payment of service charges for visits by WCVT or its subcontractors to your premises when a service request results from causes not attributable to WCVT or its subcontractors.

Non-Recommended Configurations. Customer Equipment that does not meet WCVT's minimum technical or other specifications constitutes a "Non-Recommended Configuration." Neither WCVT nor any of its affiliates, suppliers or agents warrant that a non-recommended configuration will enable you to successfully install, access, operate or use the services. You acknowledge that any such installation, access, operation, or use could cause Customer Equipment to fail



to operate or cause damage to Customer Equipment, you, your premises, or WCVT equipment. Neither WCVT nor any of its affiliates, suppliers or agents shall have any liability whatsoever for any such failure or damage. WCVT reserves the right to deny you customer support for the Services and/or terminate Service(s) if you use a Non-Recommended Configuration.

No Unauthorized Devices or Tampering. You agree not to attach any unauthorized device to WCVT Equipment or the Services. If you make any unauthorized connection or modification to WCVT Equipment or the Services or any other part of our network, we may terminate your Service and recover such damages as may result from your actions. Unless expressly authorized by us, you agree not to install anything to intercept or receive any of the Services offered over our network or to assist any person in intercepting or receiving any of the Services offered over our network. You also agree that you will not attach anything to the Inside Wiring, WCVT Equipment or Customer Equipment, whether installed by you or us, which singly or together impairs the integrity of our network or degrades our network's signal quality or strength or creates signal leakage.

You hereby agree that we may recover damages from you for tampering with any WCVT Equipment or any other part of our network or for receiving unauthorized Service(s). You agree that it would be difficult if not impossible to calculate precisely the lost revenue resulting from your receipt of unauthorized Service(s) or the alteration or improper use of WCVT Equipment. You therefore agree to pay us as liquidated damages, the sum of \$500.00 per device used to receive the unauthorized Services in addition to our cost to replace any altered, damaged, or unreturned WCVT Equipment or other equipment owned by WCVT, including any incidental costs. The unauthorized reception of the Services may also result in criminal fines and/or imprisonment.

<u>Inside Wiring.</u> You may install Inside Wiring, such as additional cable wiring and outlets, provided it does not interfere with the normal operations of our network. If you have us install Inside Wiring, we will charge you for that service. Regardless of who installed it, we consider the Inside Wiring your property or the property of whomever owns the Premises. Accordingly, you are responsible for the repair and maintenance of the Inside Wiring, unless you and WCVT have agreed otherwise in writing. (If you do not own the Premises, contact your landlord or building manager about the repair or maintenance of Inside Wiring.) If you have us repair or maintain the Inside Wiring, we will charge you for that service.

Use of Services

You will not use the WCVT Equipment at any time at an address other than the Premises without our prior written authorization. You will not use or permit another to use the WCVT Equipment or the Service(s), directly or indirectly, for any unlawful purpose, including, but not limited to, in violation of any posted WCVT policy applicable to the Services. Use of the WCVT Equipment or Services



for transmission, communications or storage of any information, data, or material in violation of any U.S. federal, state or local regulation or law is prohibited.

You acknowledge that you are accepting this Agreement on behalf of all persons who use the WCVT Equipment and/or Services and that you shall have sole responsibility for ensuring that all other users understand and comply with the terms and conditions of this Agreement and any applicable WCVT policies including, but not limited to, acceptable use and privacy policies. You further acknowledge and agree that you shall be solely responsible for any transactions, including, without limitation, purchases made through or in connection with the Services. You agree to indemnify, defend, and hold harmless WCVT and its affiliates, suppliers, and agents against all claims and expenses (including reasonable attorney fees) arising out of the use of the Services, the WCVT Equipment and/or the Customer Equipment or the breach of this Agreement or any of the applicable WCVT policies by you or any other user.

Acceptable Use Policy

The WCVT Acceptable Use Policy ("AUP") and other policies concerning Broadband are posted on the Service's Web site at https://www.wcvt.com/policies/ (or an alternative Web site if we so notify you). You further agree that WCVT may modify the AUP or other policies from time to time. Notwithstanding anything to the contrary in this Agreement, YOU ACKNOWLEDGE AND AGREE THAT THE TERMS OF THE AUP AND ANY OTHER APPLICABLE WCVT POLICIES MAY BE PUT INTO EFFECT OR REVISED FROM TIME TO TIME WITHOUT NOTICE BY POSTING A NEW VERSION OF THE AUP OR POLICY AS SET FORTH ABOVE. YOU AND OTHER USERS OF THE SERVICE SHOULD CONSULT THE AUP AND ALL POSTED POLICIES REGULARLY TO CONFORM TO THE MOST RECENT VERSION.

Robocall Mitigation

Illegal Robocalls are calls generated by auto dialers to telephone numbers for commercial purposes without the permission of the telephone number owner. These calls may be from a recorded voice or be auto transferred to a live agent; they will often appear from a disguised originating number; and they will either claim a pre-existing business relationship ("car warranty" or "Microsoft refund") or disguise their commercial intent with false claims of fraud.

We are legally obligated to prevent our service(s) from being used for illegal robocalling. We may deny service to you if we believe the use of the service will be for the generation of illegal robocalls. We are permitted to investigate any claims or suspicion of robocalling in whatever manner we believe is appropriate based on the nature of the claim and may share information about your network utilization with third parties as required by law. During our investigation we may contact you about any complaint we may receive about your use of our service for illegal robocalling. If we are unable to resolve the complaint or you fail to respond to us, we may suspend or terminate your service with or without advanced notice. AT

Emergency 911 Services on VOIP

We provide both circuit-switched local telephone services (traditionally referred to as "plain old telephone") as well as local services that utilize the internet to provide telephone line or Hosted PBX services, commonly referred to as VOIP.

Our local telephone services allow you to connect 911/E911 emergency services. The 911/E911 services provided to you as VOIP differs from that provided as traditional phone service.

BY USING THE SERVICE YOU ACKNOWLEDGE AND ACCEPT ANY LIMITATIONS OF 911/E911. YOU AGREE TO CONVEY THESE LIMITATIONS TO ALL PERSONS WHO MAY PLACE CALLS OVER THE SERVICES. IF YOU HAVE ANY QUESTIONS ABOUT 911/E911, YOU MUST CALL US AT 802-496-3391.

<u>Acknowledgement and warning labels.</u> By using our VOIP services, you acknowledge that you are responsible for notifying all potential users who may place calls using your VOIP of the 911 limitations. You are responsible for any notices of the potential lack of 911/E911 operation to any users of your VOIP service regardless of whether or not you have properly labelled your equipment.

<u>Non-voice systems.</u> You acknowledge that the services are not set up to function with non-voice services such as home security systems, medical monitoring equipment, TTY equipment, or entertainment or satellite television systems. We are not liable for interruption or disruption of such systems by the services.

911/E911 limitation of liability and indemnity. In addition to limits of liability and indemnification that may be contained elsewhere in this Agreement, you agree that we are not liable for any service outage or inability to dial 911 or any other emergency telephone number due to the conditions described in this section. You agree to defend, indemnify and hold harmless us, our owners, managers, officers, directors, employees, affiliates and agents, and any other service provider who furnishes services to you or a user in connection with the services, from any and all claims, actions, losses, damages, fines, penalties, costs and expenses (including, without limitation, attorneys' fees) by, or on behalf of, us or any third party or user of the service relating to 911 dialing or the inability to access or reach emergency 911 services.



Fraudulent Call and Network Security

You shall manage without limitation the integrity of the traffic in and out of your network and are wholly responsible for the security of your phone system, including VOIP, Hosted PBX and/or local area network (LAN). You shall manage and correct as necessary any fraudulent calling patterns or calling patterns perceived as fraudulent that may harm or adversely affect us or our network and you shall use best efforts to prevent and detect network looping. With services inclusive of long distance calling, all unauthorized domestic and international usage and subsequent charges incurred by you as a result of hacking or intrusion into your phone system are your sole responsibility and liability.

In the event that you fail to comply with the requirements described above, we shall have the right (but not the obligation) to take protective action against customer in order to protect our network. Such protective action may include, without limitation the temporary blocking of your traffic until such time that we below that the applicable problem has been resolved. We shall use commercially appropriate efforts to notify you if such an action will be taken.

Assignability

This Agreement and the Services furnished hereunder may not be assigned by you. You agree to notify us immediately of any changes of ownership or occupancy of the Premises. We may freely assign our rights and obligations under this Agreement with or without notice to you.

Termination of This Agreement

Term. This Agreement will be in effect from the time that charges commence until (i) it is terminated as provided for by this Agreement or by any addendum to this Agreement or (ii) it is replaced by a revised Agreement. If you self-install WCVT Equipment, Service charges begin the earliest of (i) the day on which you picked up WCVT Equipment at our service center, (ii) the day you install the Service, or (iii) five (5) days after the date we ship the WCVT Equipment to you. If you self-install a Broadband modem or converter that you obtained from a source other than WCVT, charges begin the day that your order for the Services is entered into our system. The option to self-install a Broadband modem or converter and/or to use a non-WCVT-supplied Broadband modem or converter is subject to availability. Any non-WCVT supplied Broadband modem or converter must comply with WCVT's minimum requirements.

<u>Termination by You.</u> Unless you have committed to a minimum term and have yet to complete your commitment to us, you may terminate this Agreement for any reason at any time by notifying WCVT in one of three ways: (i) send a written notice to the postal address of your local WCVT business office; (ii) send an electronic notice through the "Contact" page found on www.wcvt.com; or (iii) call our customer service line during normal business hours. Subject to applicable law or the terms of any agreements with governmental authorities, all applicable fees and



charges will accrue until this Agreement has terminated, the Services have been disconnected, and all WCVT Equipment has been returned. We will refund all prepaid monthly service fees charged for Services after the date of termination (less any outstanding amounts due WCVT for the Services, affiliate services, WCVT Equipment, or other applicable fees and charges).

<u>Denial of Service by WCVT.</u> WCVT may refuse to furnish or may deny Service to any persons, firm or corporation who, either, over the facilities furnished by the WCVT or, in the course of business communications with WCVT regarding facilities and services, uses or permits to be used foul, abusive, obscene, threatening, and/or profane language; or impersonates or permits others to impersonate any other individual with fraudulent or malicious intent. Such Denial will be treated as a Termination of Service under this Agreement.

Suspension and Termination by WCVT. Under the conditions listed below, WCVT reserves the right, subject to applicable law, to act immediately and without notice to terminate or suspend the Services and/or to remove from the Services any information transmitted by or to any authorized users (e.g., email or voicemail). WCVT may take these actions if it: (i) determines that such use or information does not conform with the requirements set forth in this Agreement, (ii) determines that such use or information interferes with WCVT's ability to provide the Services to you or others, (iii) reasonably believes that such use or information may violate any laws, regulations, or written and electronic instructions for use, or (iv) reasonably believes that such use or information interferes with or endangers the health and/or safety of our personnel or third parties. WCVT's action or inaction under this Section shall not constitute review or approval of your or any other users' use of the Services or information transmitted by or to you or users.

<u>Your Obligations upon Termination.</u> You agree that upon termination of this Agreement you agree to the following:

i) you will immediately cease all use of the Services and all WCVT Equipment; ii) you will pay in full for your use of the Services up to the date that this Agreement has been terminated and the Services are disconnected; and iii) you will be billed and pay for any WCVT equipment not returned to WCVT on the date of service termination at current value of such WCVT equipment. Equipment returned must be in working order, normal wear and tear excepted. You may also be charged incidental costs that we incur in replacing the WCVT Equipment. Upon our request, you will permit us and our employees, agents, contractors, and representatives to access the Premises during regular business hours to remove the WCVT Equipment and other material provided by WCVT. We will conduct this removal at a time agreed on by you and us, and you will ensure that all WCVT Equipment is returned to WCVT. If the Equipment is returned within sixty (60) days of termination, any fees charged for the Equipment will be refunded (other



than fees for damages). No refunds will be made for any Equipment returned more than sixty (60) days after termination.

<u>Early Termination</u>.
